RE: AUTHORIZE GRADE CHANGE FOR THE FOOD SERVICE COORDINATOR POSITION FROM GRADE 8 TO GRADE 9 – CIVIL SERVICE/HUMAN RESOURCES DEPARTMENT

WHEREAS, the Schuyler County Office for the Aging is responsible for the administration and oversight of nutrition services and related programs serving older adults throughout Schuyler County; and

WHEREAS, the office's Food Service Coordinator position plans, coordinates and works to ensure compliance with federal, state, and local regulations governing congregate and home-delivered meal programs, and

WHEREAS, the Food Service Coordinator position is currently a Grade 8 in the County's wage grade structure in the CSEA Administration Unit contract, and

WHEREAS, the responsibilities of the Food Service Coordinator have expanded to include direct supervision of nutrition program staff, oversight of daily kitchen operations, coordination of staff and volunteer schedules, monitoring of performance, and ensuring program quality and compliance, and

WHEREAS, the addition of supervisory duties represents a significant increase in responsibility and scope of work beyond the current classification and salary grade, and

WHEREAS, the Director of the Schuyler County Office for the Aging, in conjunction with the Personnel Officer, and approval of the County Administrator, have reviewed the proposed changes and supports the reclassification and grade adjustment to a Grade 9 in the County's wage grade structure in the CSEA Administrative Unit contract, and

WHEREAS, the recommended change in grade will result in an hourly wage rate for 2026 of \$29.48, an increase of \$1.87/hr.
